The undersigned confirms that he/she does not have nothing to claim on the grounds of the aforementioned and irrevocably waive any right, action or claim arising from the above authorized.

This authorization does not allow the use of images and videos in contexts that affect the personal dignity and decorum of the child and in any case for use and / or purposes other than those indicated above.
